## **Preamble**

The undersigned, hereinafter referred to as "Partners":

Yaroslav-the-Wise Novgorod State University, Russia,

University of Wroclaw, Poland

- \* Recognizing the mutual interests in the fields of research, development, education, training, transfer of technology and dissemination of knowledge on long term, and also,
- \* Recognizing the importance of universities role in promotion of international collaboration and increased contribution to society development and whereas
- \* Both partners have common overall objectives, have an overlapping scope of activities, and are working with potentially complementary methodologies, while Yaroslav-the-Wise Novgorod State University and University of Wroclaw, Poland have long term experience in collaboration in the field of education, research and advisory services.

Now, Yaroslav-the-Wise Novgorod State University, Russia and University of Wroclaw, Poland hereby agreed to enter into this Memorandum of Understanding to provide a framework of collaboration between both partners, allowing them the opportunity to develop and implement mutually beneficial and agreed upon activities, according to the terms and conditions set out in the following articles.

## Article 1. FIELDS OF COOPERATION

Collaboration and co-development between the two universities will be established within any field of common interest:

- 1. Exchange of faculty members and staffs.
- 2. Exchange of students.
- 3. Development of joint scientific activities and / or publications

4. Cooperative development of seminars / workshops and academic meetings.

5. Development of joint training programs.

6. Cooperative development of special short-term academic and cultural programs.

Article 2. EXECUTIVE OF THE MEMORANDUM

The specific activities to be carried out under this Memorandum will be stated in corresponding

specific sub-agreements. The sub-agreements will be signed between the two universities.

**Article 3. SPECIFIC AGREEMENTS** 

The specific agreements between both universities will specify their objectives, conditions and ways of execution, financial support, validity and administrative rights and responsibilities

within each university.

**Article 4. TERMS AND TERMINATION** 

This Memorandum will be effective on the date it has been signed by both parties, and it will be in effect for a period of 5 years. The agreement can be renewed for additional 5 year periods by

mutual consent of the parties. Both parties reserve the right to terminate this agreement upon discussion with the others three months prior to the termination date becoming effective.

Moreover, if either side likely to terminate this agreement earlier within the agreement period

of validity, a six months written notice prior to the termination date is necessary.
